AN ORDINANCE AMENDING CHAPTER 15, MOTOR VEHICLES, PART 8, STREET CLEANING, OF THE STATUTORY CODE OF HANOVER TOWNSHIP

Hanover Township, Lehigh County, hereby ordains that Chapter 15, Motor Vehicles, Part 8, Street Cleaning, of the Statutory Code of Hanover Township, is hereby amended by adding the portions underlined as follows:

Part 8 Street Cleaning

Section 801. Definitions. For the purposes of this Part the following definitions apply:

Alternate Parking Area – an area owned by the Township for the parking of vehicles during street cleaning operations.

Person – any individual, corporation, association, cooperative, partnership, or similar group or entity.

Prohibited Parking Area – streets or portions of streets designated in or pursuant to Section 803 of this Part.

Street – that portion designated for the movement of vehicular traffic on a public right-of-way legally open or officially plotted by the Township which is owned by the Township whether acquired by purchase, gift, declaration, condemnation, or other means.

<u>Section 802. Declaration of Street Cleaning.</u> By posting Notice on Township streets, the Township shall establish parking restrictions for street cleaning purposes the first and third week of each month from April through November <u>1st</u> of a calendar year on the streets set forth in Section 803.

<u>Section 803.</u> Designation of Prohibited Parking Areas. For the purposes of this Part, the following streets or portions of streets shall be prohibited parking areas during the periods shown:

<u>Section 804. Prohibition of Parking.</u> During designated street cleaning days and times, no person shall park or permit a vehicle registered in the name of such person to remain parked in a prohibited parking area. Such prohibited parking area shall be a towaway zone.

Section 805. Off-Street Parking Areas

1. Alternate Parking Areas. The parking areas located in each public park shall be available for parking. All vehicles must be removed from the alternate parking areas within 24 hours after the cessation of street cleaning.

Section 806. Penalties. Any person, firm, or corporation who shall violate any provision of this Part 8 shall, upon conviction thereof, be sentenced to pay a fine of not more than three hundred dollars (\$300.00) and/or imprisonment for a term not to exceed ninety (90) days. Provided: it shall be the duty of the code enforcement personnel of the Township to report to the appropriate official all such violations, indicating, in each case: the Section violated, the license number of the vehicle involved in the violation; the location where the violation took place; and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation. The code enforcement officer shall also attach to or place upon every such vehicle a notice stating that the vehicle was parked in violation of this Part. The notice shall contain instructions to person, firm or corporation that if he will report to the Township office and pay the sum of twenty-five dollars (\$25.00) within seventy-two (72) hours after the time of the notice, or pay the sum of fifty dollars (\$50.00) between seventy-two (72) hours and fourteen (14) days from the date and time of the notice, that act will save the violator from prosecution and from payment of the fine and costs prescribed in the first sentence of this Section. Every day that a violation of this Part 8 continues shall constitute a separate offense.
