AN ORDINANCE APPROVING SOLICITATION OF BIDS FOR A CONTRACT FOR CONSTRUCTION OF THE LLOYD STREET MILLING AND OVERLAY PROJECT, A PUBLIC CAPITAL IMPROVEMENT, TO BE SUBSTANTIALLY IN THE FORM PROVIDED TO COUNCIL, ITS APPROVAL IN AN AMOUNT NOT TO EXCEED \$700,000, SUBJECT TO CERTAIN CHANGE ORDER AND UNIT PRICE ADJUSTMENTS, AND ITS AWARD BY RESOLUTION OF COUNCIL AFTER PUBLIC BIDDING

HANOVER TOWNSHIP HEREBY ORDAINS

WHEREAS, Hanover Township intends to contract for construction to mill and overlay of a portion of Lloyd Street, a public capital improvement (the "Project"); and

WHEREAS, Section 8.01 of the Hanover Township Charter requires that contracts for construction of public capital improvements be approved by ordinance; and

WHEREAS, the Township Engineer has prepared a contract with specifications for construction of the Project and recommended approval by Council of any contract that is substantially in accordance with its terms and conditions as determined by the Township Engineer (the "Contract"); and

WHEREAS, Council intends to solicit bids for construction of the Project pursuant to terms and conditions of the Contract;

NOW THEREFORE, HANOVER TOWNSHIP HEREBY ORDAINS as follows:

Section 1. The solicitation of public bids for construction of the Project pursuant to the Contract is authorized pursuant to Chapter 1, Part 2 of the Statutory Code of Hanover Township, provided the Township Engineer certifies to Council that the Contract is substantially in accordance with the terms and conditions of the contract recommended.

- Section 2. The Contract for the Project at a price determined by public bidding is approved, provided the price does not to exceed Seven Hundred Thousand Dollars (\$700,000), subject to adjustments as follows:
- A. After the Contract has been executed, the Township Manager may approve change orders not to exceed in the aggregate a net increase of ten percent (10%) of the Contract price.

B. Where the Contract price includes unit prices for an estimated number of units required, payment of costs resulting from exceeding the anticipated number of units shall not be subject to the maximum price or change order limit.

Section 3. The Contract shall be awarded by resolution of Council.
